REFUND POLICY

Swimming Lessons/Special Programs under \$75.00: A non-refundable fee of \$10.00 will be levied on all refund/credit note requests of lessons \$55.00 and under, and \$20.00 for all programs over \$55.00. Refunds with less than 7 days' prior to the start date of the program will be charged 50% of the program fee. No refund will be issued after the start date of a program, except for medical reasons (doctor note required). Administration fees will be charged for any refunds or transfers, including doctor's notes.

Leadership Courses/Special Programs over \$75.00: Any refunds requested 2 weeks prior to the start date will be charged 50% of the registration fee, including manuals. There will be no refunds issued after the start of the program, except for medical reasons (doctor note required). Administration fees will be charged for any refunds or transfers, including doctor's notes.

To receive a refund/credit note, the customer's confirmation copy of the registration must be returned. The Humboldt Aquatic Centre reserves the right to charge a \$10 transfer fee to switch to a different class or session.
