1.0 PURPOSE

The City deems it expedient to make policy governing the management, maintenance, improvement, operation, control and use of these properties and facilities. To ensure equal opportunity for organization and community members to utilize these recreational facilities.

2.0 GENERAL POLICY

- 2.1 Users will be responsible for all damages to facilities and equipment
- 2.2 Persons under the age of 15 must be accompanied by an adult or instructor and no one under the age of 12 is permitted in the Fitness Room without prior authorization from the Community and Leisure Services Director.
- 2.3 Maximum capacity of the fitness room is 55 persons at any one time.
- 2.4 All facility rules and regulations are to be adhered to.
- 2.5 Equipment is to be used the way in which it is intended, if there is miss use of equipment department staff have the right to remove individuals from the facility.
- 2.6 The City reserves the right to evict, cause to be removed, or refuse further usage to person(s)/group(s) causing willful damage or contravening the facility regulations.



- 2.7 Proper attire must be worn, including shirts and clean footwear.
- 2.8 Patrons are not to use the equipment unless they are in proper condition and have knowledge regarding the use of the equipment.
- 2.9 Patrons that have health conditions should consult with their physician before using the fitness room and the equipment.
- 2.10 No food, smoking, alcoholic beverage or glass containers permitted in the Fitness Room.
- 2.11 Due to health regulations, pet are not allowed in the facility of Fitness Room.
- 2.12 Patrons are expected to report damaged or dangerous equipment to facility operators immediately.
- 2.13 Patrons are expected to wipe down the equipment with the spray bottles and cloths provided in the Fitness Room before and after every use.
- 2.14 Patrons with open sores, infection and contagious diseases are prohibited from entering the Fitness Room.
- 2.15 The Fitness Room must meet all Saskatchewan Health regulations.
- 2.16 No alcoholic beverages are allowed in the facility or patrons who are suspected to be under the influence of alcohol or other substances.
- 2.17 If a patron poses a threat of safety to other patrons or staff, the patron will be asked to leave the premises and the RCMP will be contacted immediately.
- 2.18 In the event of an incident, accident or loss, emergency process will be followed and proper forms filled out and forwarded to the Community and Leisure Services Administration Office.



- 2.19 Management has direct authority of the facility and the equipment. This area is not supervised. If you are unfamiliar with the equipment, please refrain from usage until you have received proper instructions.
- 2.20 The Fitness Room is a public facility and we ask that patrons respect other patrons and the facility. If there are situations of harassment or conflict with other users, these individuals will be asked to leave the facility.
- 2.21 The City of Humboldt has entered into a Joint Usage Agreement with the schools and college in the city on the usage of the facility.
- 2.22 The City of Humboldt has agreements with the Humboldt Broncos and Health Region on programs they provide within the City of Humboldt.
- 2.23 No external stereo or music equipment is permitted in the Fitness Room. Fitness Room stereo and televisions are provided for use by the patrons.
- 2.24 Facility closures and programs cancellations may occur. The City reserves the right to cancel programs or close all or part of any facility due to maintenance and/or special bookings. Passes of all kinds will not be extended nor will the holder be compensated for facility closures of fewer than five consecutive days or program cancellations.
