BYLAW NO. 01/2019

A BYLAW TO AUTHORIZE AMENDMENTS TO BYLAW NO. 04/2016, BEING A BYLAW TO REGULATE DEVELOPMENT IN THE CITY OF HUMBOLDT, TO PROVIDE FOR THE AMENITY OF THE CITY AND THE HEALTH, SAFETY AND GENERAL WELFARE OF THE HABITANTS CITED AS THE ZONING BYLAW

The Council of the City of Humboldt, in the Province of Saskatchewan, enacts as follows:

1. **Table 10-1: - R1 LOW DENSITY RESIDENTIAL DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8” to Category “17”.
2. **Table 10-2: - R2 MEDIUM DENSITY RESIDENTIAL DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8” to Category “17”.
3. **Table 10-3: R3 - CORE MIXED RESIDENTIAL DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8 ⁽⁵⁾” to Category “17 ⁽⁵⁾”.
4. **Table 10-4: R3A - SMALL LOT RESIDENTIAL DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8” to Category “17”.
5. **Table 10-5: R4 - ACREAGE RESIDENTIAL DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8” to Category “17”.
6. **Table 10-6: R5 - MANUFACTURED HOME RESIDENTIAL DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8” to Category “17”.
7. **Table 10-8: C2 - MEDIUM DENSITY COMMERCIAL DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8” to Category “17”.
8. **Table 10-9: C3 - COMMERCIAL / INDUSTRIAL MIXED-USE DISTRICT DEVELOPMENT STANDARDS** is amended by changing the Parking Category for Place of worship from Category “8” to Category “17”.
9. **Section 3.16.2(1)(g) Development Appeal Fee** is amended by deleting “\$50.00” and inserting \$300.00 thereon.
10. This Bylaw shall come into full force and take effect immediately upon the final passing thereof.
