**PLANNING COORDINATOR'S REPORT: DISCRETIONARY USE** APPLICATION-**PROPOSED AUTOMOTIVE SALES ESTABLISHMENT - 739** 16<sup>™</sup> STREET

Nordick/Behiel:

That Council approve the Discretionary Use Application to allow an Automotive Sales Establishment at the property located at 739 16th Street – legally described as Lot 1A, Block 47 Plan No. 99401872; subject to:

- 1) the display and sale of only automotive vehicles, and operation of a service bay or the storage of fuel on site,
- 2) the approval of all necessary permits, including a development permit (with accompanying approved drainage plan),
- 3) the access to the site being along 16th Street (along the eastern property boundary) with a minimum setback of 55 meters from the 8<sup>th</sup> Ave/16<sup>th</sup> Street intersection.

- 4) The temporary modular office building:
  - Being reviewed and/or visually inspected by the City prior to being transported into the City and being to the satisfaction of the City regarding its structural condition and visual appeal,
  - ii. being issued a move-in permit from the City prior to being transported into the City and being placed on site.
  - iii. being placed and restricted to the far southern portion of the site,
- the City provided with a landscaping plan that satisfactorily demonstrates
  - i. how the site will always continue to be suitably maintained in a neat and tidy condition,
  - ii. that landscaping meets the requirements of the Zoning bylaw prior to operation of this use,
- 6) a maximum inventory of the 12 vehicles (excluding staff and customer vehicles) be permitted on site at any given time, and that all vehicles be accessible to the internal aisle, and
- 7) the provision for a minimum of 3 (three) off-street parking space for staff and customer.
