RECOMMENDATION

RECOMMENDATION

Approve the purchase of a salt/sand spreader at a cost of approximately \$18,450 plus applicable taxes from Commercial Truck Equipment.

BACKGROUND

The existing spreader was purchased in 2014 and is due for replacement. The sander has broken down more often than desired and is currently out of service and requiring repairs at a cost of approximately \$4,000 in parts plus our mechanic's time.

CURRENT SITUATION

The city was approached by Commercial Truck Equipment in Regina because they had new salt/sand spreaders on discount as the season was near its end.

The Buyers SaltDogg 5.5 cubic yard stainless steel, electric drive salt/sander will fit our new truck and is currently on clearance for \$18,450 plus tax. Commercial Truck is holding the sander for the city pending decision of this report. It will be ready for the 2024/2025 winter season. The old sander will be sold through a public bidding process.

FINANCIAL IMPLICATION

This item was not in the 2024 budget for replacement, however, is listed within the fleet plan. There have been annual contributions to the fleet plan for a sander replacement. The sander was initially planned for replacement in 2024 but was deferred.

The cost is \$18,450 plus tax. The retail is \$25,088.46 plus tax. This is a savings of \$6,638.46.

CONCLUSION

The sander is the same brand name as our current sander and built from quality materials. Staff are anticipating the new electric drive to be more durable when exposed to the harsh salt/sand conditions it experiences throughout the winter.
