RECOMMENDATION

BACKGROUND

In June 2024, City Council approved Bylaw No. 06/2024 to authorize borrowing up to \$12 million for the construction of a new Wastewater Treatment Facility and necessary upgrades to Lift Stations 1 and 4. The bylaw outlined the terms of the borrowing, including the interest rate, repayment schedule, and other relevant details.

CURRENT SITUATION

Initially, the City planned to secure a fixed-rate multi-draw construction loan with RBC Royal Bank. However, while executing the agreement, RBC identified they were unable to offer the originally proposed terms as the agreement was now a legacy product.

To address this challenge and potentially minimize financial costs, the City and RBC are negotiating an alternative financing arrangement: a facility loan. This loan would allow the City to draw funds as needed, with interest rates tied to the Canadian Overnight Repo Rate Average (CORRA) plus a premium of 1-1.25%. At the time of writing this report, the CORRA is 4.3%

There are some potential advantages to the City with this new agreement, by linking the interest rate to the CORRA, the City would be required to lock in the interest rate on 30-or 90-day terms and could benefit from potentially lower borrowing costs, especially if market interest rates decrease throughout construction. A facility loan offers flexibility in terms of multiple draws by allowing the City to access funds as required and not withdraw the funds up front while accruing interest throughout the construction process.

Amendments to the bylaw are required as the interest rate terms of the borrowing would





change under this agreement.

COMMUNICATION AND ENGAGEMENT

As per City Policy #4475, public notice was issued that this bylaw is to be heard tonight, and the required 10-day window has been met.

FINANCIAL IMPLICATION

While the exact financial impact of the facility loan will depend on future interest rate movements and the specific terms of the agreement, the potential for lower interest costs could result in savings for the City from the terms that were laid out in the original bylaw.

CONCLUSION

This report provides necessary background information for Bylaw No. 10/2024, which aims to amend the original borrowing bylaw to accommodate the proposed facility loan. By adopting this revised approach, the City can execute the agreement to provide the funding required for the Wastewater Treatment project.

A BYLAW OF THE CITY OF HUMBOLDT TO PROVIDE FOR THE BORROWING OF FUNDS FOR THE PURPOSE OF FINANCING THE WASTEWATER TREATMENT FACILITY AND UPGRADES TO LIFT STATIONS 1 AND 4

The Council of the City of Humboldt in the Province of Saskatchewan enacts as follows:

- 1. This bylaw shall be referred to as the 2024 Wastewater Treatment Facility Borrowing Bylaw.
- 2. In this bylaw:
 - a. "Council" shall mean the council of the City;
 - b. "City" shall mean the City of Humboldt;
- 3. The Council of the City hereby authorizes borrowing up to Twelve Million Dollars [\$12,000,000] in Canadian funds for the purposes set forth herein,
 - The design and construction of a wastewater treatment facility and upgrades to lift stations 1 and 4.
- 4. The loan shall be a construction loan for a term of up to 24 months, bearing interest at a rate up to 5.41% compounded monthly with interest only payments due monthly.
- 5. The Saskatchewan Municipal Board has approved a debt limit of Fifteen Million Dollars (\$15,000,000) for the City of Humboldt and the borrowing contemplated herein is within the debt limit approved by the Saskatchewan Municipal Board.
- 6. The source of funding for repayment will be from User Fees and Taxation and Grant Revenues.
- 7. The City Manager and/or City Controller shall execute all contracts, documents and agreements necessarily incidental to the operation of this Bylaw on behalf of the City.

The Saskatchewan Municipal Board has approved a debt limit of Fifteen Million Dollars (\$15,000,000) for the City of Humboldt and the borrowing contemplated herein is within the debt limit approved by the Saskatchewan Municipal Board.

4. That the following section 5 be added:
